

The Impact of a Donor Advised Fund

Naomi Vilko opened a Donor Advised Fund (DAF) at the Jewish Community Foundation of Greater Mercer in 2016, and since then she has recommended more than 100 grants to charities near to her heart. Let's hear directly from Naomi about how she has used her DAF.

You recently used your DAF to fund the film, A Train Near Magdeburg. How did you get connected with this project? had been looking for my cousin, Ervin Abadi, for 50 years. During the pandemic, I finally learned the miraculous story of how he was liberated by American GIs from certain death during WWII. He was enslaved, starved and tortured by the Nazis because he was a Jew. I want people, especially our youth, to know that we may be faced with difficult choices, and that ordinary people can do extraordinary things. The book by Matt Rozell and the documentary film provide this much needed education.

Why is a DAF an effective way to support the causes you care about? feel it is my responsibility to give charity when I can. The DAF simplifies both donations and record keeping. and it's very easy to transfer securities and cash. After I'm gone, my children will have a record of the causes that I support and can continue to donate to them through the DAF.

End of Year Checklist

As the end of 2021 approaches, please review this checklist to maximize benefits and stretch your charitable giving dollars.

- (1) Avoid paying capital gains tax on longterm appreciated stock and transfer those assets to a Donor Advised Fund (DAF) at the Jewish Community Foundation of Greater Mercer
- (2) Maximize tax benefits by concentrating or "bunching" multiple years of charitable gifts in a DAF and then itemize vour deductions
- (3) Use the Required Minimum Distribution (RMD) from your IRA to support a favorite charity or transfer those assets to a Designated Fund at JCFGM, and avoid paying taxes on that income
- (4) Submit all DAF agreements, contributions to funds and recommended grants by Tuesday, **December 14** to allow Foundation staff time to process all transactions
- (5) When making a contribution to a fund by check, please make check payable to Jewish Community Foundation of Greater Mercer, note your fund name in the memo line and mail to JCFGM, 457 Nassau Street, Princeton, NJ 08540
- (6) When transferring securities to your fund, please use this account info:
