# JEWISH COMMUNITY FOUNDATION OF GREATER MERCER MINUTES OF BOARD OF TRUSTEES MEETING

# Wednesday September 22, 2021

President Chip Leob welcomed everyone to the call. The President determining that a quorum was present, called the meeting to order at 7:30m via Zoom webconference and reviewed the Foundation mission statement.

# 1. Minutes of the June Meeting

Corrections: Date should be Monday, June 21; Walter Yosafat was in attendance; The Investment Committee report should read: As part of its succession planning, the committee announced the transition of its chairman from Marty Schwarz to Harvey Fram. Marty will remain on the Committee.

The minutes were approved as amended.

### 2. Fund Activity - Harvey Fram

Between July 1 and September 14, the Foundation opened 7 new custodial funds and 1 DAF, all from the Somerset Hunterdon Warren region. \$64,000 was deposited in existing DAFs. Total funds number 133, Total Foundation funds are \$15,606,643. Two additional funds are pending.

### 3. Investment Committee Report - Harvey Fram

Harvey Fram delivered the report on the Investment Committee meeting September 13. The committee will perform a deep dive into all of their funds are performing and examining possible change ups.

#### 4. Staff Reports

**Each one Reach One** - Amy Zacks reported on the Grinspoon Foundation's new challenge campaign to energize the Life and Legacy Program, our efforts to increase legacy donations, and what Board members can do.

**Facebook Campaign** - Kim Marks reported on our new social media campaign and how Board members can participate. She is planning an Instagram account, but does believe that a Twitter account will be beneficial.

### 5. President's Report - Chip Loeb

**Federation Distribution checks** - Chip Loeb hand delivered the Federation distribution checks for 2021 and had a discussion with Dan Herscovici, the incoming Federation President on how the Foundation determines

the amount of the distributions.

**Proposed Grant to Federation for Life and Legacy** - As The Jewish Federation PMB was unable to fully participate in the Life and Legacy program in 2012, the Foundation will create a new program:

Proposal: To initiate a strong L&L promise campaign that would include Lion of Judah and PACE fund gifts which would become part of the JCFGM portfolio. The proposal is for JCFGM to provide a three years of a \$2,500 incentive grant to the Federation to have its development staff focus on legacy giving, with a commitment from Federation that all resulting funds would be held by the Foundation.

Discussion: The Board concurred with the concept, but agreed that some structure would be needed.

Motion: To approve the above proposal and that Chip Loeb and Linda Meisel should collaborate with the Jewish Federation PMB to develop an MOU setting forth metrics to earn the grant.

Motion - Joanne Snow Second - Michael Manning

Abstaining: (all members of both boards) Michael Feldstein, Howard Cohen, and Dan Liebowitz. All other members voted in favor

**Proposal for Teen Mitzvah Fund** - Proposed by Jewish Federation PMB to help make local teen B'nai mitzvah experiences more meaningful, and to educate these young adults about the importance of charitable practices the Federation and the Foundation would introduce a program that creates the opportunity for Jewish teens to open charitable giving accounts. The accounts would be funded by the teen , the Federation and the Foundation. Families would be requested to contribute as well. Students would be encouraged to participate in the JCYF program. Donations could only be made at the High Holidays and Hanukkah. The Foundation would agree to waive fees for 5 years, waive the minimum fee for 5 years and reduce the minimum donation to \$36. Planned Kickoff is Hanukkah 2021.

Discussion: It was the sense of the Board to move forward with the program and work out the details with Federation and JCYF.

**Strategic Planning Initiative** - Susan Falcon led the discussion on clarifying and moving forward with the proposed Strategic Plan.

# 6. Treasurer's Report - Joyce Kalstein

As of 8/31 there is a projected deficit of \$1600 in the operating budget.

#### 7. Committee Reports

**Audit Committee -** Mark Wisotsky reported that the Committee reviewed the contract with BKC. Field work is scheduled for the week of September  $27^{th}$ , 2021

**Marketing Committee** - Linda Meisel reported that the Committee discussed the creation of a Marketing Plan Staff is working on the plan and will present it at the October Marketing Committee meeting.

#### **8. Updates -** Linda Meisel

**Ewing Property** - The Pierson Trust is interested in monetizing the asset. An appraisal had been expected, but has not yet been received.

**Back office Tech** - Stellar and FidTech have been selected to provide demonstrations for their back office software for foundations. It was noted that Renaissance has been performing better the last few months.
