1. Welcome of the President

2. Approval of Minutes

3. PACF Ad Hoc Committee Report

Linda Meisel presented to the Trustees the confidential PACF Ad Hoc Committee updates.

The PACF Ad Hoc committee reviewed PACF 990s for past 2 years, the Bylaws and governance documents including: Conflict of Interest, Confidentiality and Whistleblower. The 990s review is completes and there are no significant issues and there no donation to anti-Israel or anti-Semitic Organizations. The Bylaws and governance documents are well written and meet best practice standards. There is a high standard for conflict of interest and Jewish Community Foundation will clarify several points related to that policy.
